1. CALL TO ORDER – Mayor Jim Giganti called the meeting to order at 6:00 p.m. with Terry Allums, Brendt Murphy, Eddie Jones, Billy Helms and Betty Yoder in attendance. Also in attendance was Clerk/Treasurer Pam Ward.
2. PRAYER AND PLEDGE OF ALLEGIANCE – Brendt Murphy
3. VISITORS:
  - a. Luther Beasley – Mr. Beasley advised council of “trash pickers” who were coming through Robert’s Trailer Park and picking out white goods and spreading the garbage/trash throughout the yard. He has had two incidents where the trash pickers came into his yard and stole items. Chief Walker asked Mr. Beasley to file a complaint and would assist with issue.
  - b. Sheriff Will Maddox addressed Council with appreciation for working with Sheriff’s Department in possibly placing a hangar at the Abbeville Municipal Airport.
4. APPROVAL OF PREVIOUS MEETING MINUTES
  - a. 2/17/2014 – Regular Meeting - Upon motion by Murphy and second by Allums, the minutes were unanimously approved.
5. CLAIM FROM OSCAR BLACK IN REFERENCE TO TRAFFIC STOP – Upon motion by Allums and second by Jones, the Council unanimously denied the claim.
6. APPOINTMENT OF VOTING DELEGATE, 1<sup>ST</sup> ALTERNATE AND 2<sup>ND</sup> ALTERNATE TO THE LEAGUE CONVENTION – Mayor Giganti appointed Terry Allums as voting delegate and Billy Helms and Brendt Murphy as 1<sup>st</sup> and 2<sup>nd</sup> alternate respectively.
7. REQUEST FROM SPECTRACARE FOR USE OF THE HERNDON-WARD GYM FOR MARCH 19, 2014, APRIL 16, 2014, MAY 21, 2014 AND JUNE 4, 2014 FROM 10:00 AM.. TO 11:00 A.M.  
Upon motion by Allums and second by Yoder, the Council unanimously approved the use of the gym by Spectracare.
8. RECOMMENDATION FROM RECREATION BOARD TO APPOINT MS. CATRINA BILLINS TO THE BOARD REPLACING DONYA FLOWERS. – Upon motion by Allums and second by Yoder, the Council unanimously appointed Ms. Billins to the Recreation Board replacing Donya Flowers.
9. DISCUSSION/VOTE PURCHASING VEHICLE FOR STREET DEPARTMENT – Upon motion by Murphy and second by Allums, the Council unanimously approved the purchase of a used '94 Chevrolet pickup, V-8, 5.3 Liter extended cab for \$10,900 plus tag, title, etc.
10. DISCUSSION/VOTE ON REPLACING ROOF AT ARMORY – Council met prior to the Council meeting to review needed repairs at the Armory. Upon motion by Allums and second by Jones, the Council voted to accept the estimate by Good Cents Construction for repairs to the 18' x 100' section of the gym with a replacement metal roof in the amount of \$15,989.
11. APPROVAL OF PAID BILLS – Upon motion by Allums and second by Murphy, the Council unanimously voted to approve paid bills.
12. COMMENTS FROM COUNCIL - there were none.
13. OTHER BUSINESS AS NEEDED – Henry County Resource and Development Corporation request the use of the gym for March 17, 2014 from 9:30 – 1:00 p.m. for budget training classes. Upon motion by
