1. CALL TO ORDER - Mayor Jim Giganti called the meeting to order at 6:00 p.m. with Terry Allums, Brendt Murphy, Eddie Jones, Billy Helms and Betty Yoder in attendance. Also in attendance was Clerk/Treasurer Pam Ward.
